Certificate of completion after 6 weeks of attendance. Unless court ordered to attend more weeks. Court ordered and non-court ordered parents may attend classes.

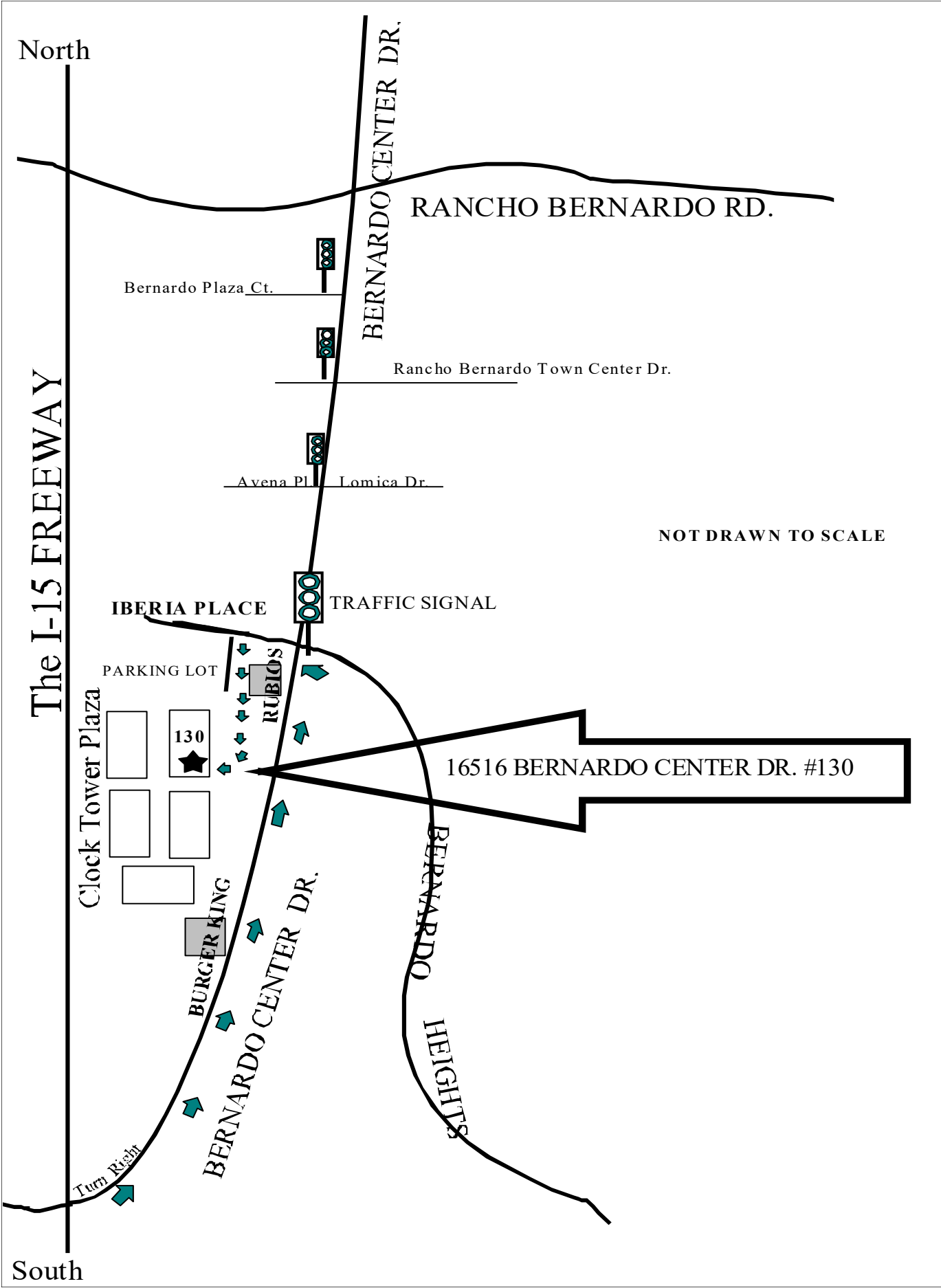
No child care is available.

Classes are facilitated by the international high conflict and conflictual coparenting trainer, Dr. Deena Stacer. A Parent Educator and High Conflict Relationship Consultant (not a therapist) and Cofounder & Director of the program. Learn to protect the children and end the conflict once and for all. A 92 page book is included. Go to parentsinconflict.com for more information regarding the interactive online courses. Online courses are located at parentsinconflict.com. Parents can choose between a 12 hour and a 50 hour course. Parents receive a certificate of completion to file with the courts in person after 6 weeks in person or online after 12 hours.

Las Vegas and Hong Kong Family Courts order parents to participate in the online courses too. Online courses cover the same material as the "live" course.

SOME OF THE COMMON ELEMENTS FOUND IN HIGH CONFLICT CASES:

- *Frequent court litigation or disputes over child sharing issues;*
- *Physical violence, intimidation, stalking or allegations of abuse, aggression, abuse, harassment or threats;*
- *Continuous and chronic co-parenting difficulties,*
- *One parent is unable or unwilling to protect the children from the conflict;*
- *One parent encourages the children to side with them;*
- *One parent is unable to separate the children's needs from their own needs;*
- *One parent is unable or unwilling to move away from conflict to build a new life;*
- *One parent refuses to share the children with the other parent;*
- *One parent has created a negative reputation with the court professionals.*
